Getting Started IT Checklist

- **Vendor Agreements or Approval**

Please submit your vendor application to hello@minga.io.

- **Data Sharing or Privacy Agreement**

Minga is registered through A4L and you can find our registered [privacy agreement here](#).

If you require a district agreement to be completed please submit it to hello@minga.io.

- **Request District Manager Account Permissions in Minga**

This provides administrative access to all schools within your district to create district-wide processes and settings. Let your Minga contact know which individuals need this access.

- **Update Web Filter/Firewall Policy and Permissions**

Please ensure Minga domains and App IDs are whitelisted and allowed through your Web or Application Filters for seamless access and integration.

- **Set Up Single Sign-On Authentication**

Configure SSO to allow users to securely access Minga with their existing district credentials.

- **Set Up Automatic Rostering**

Set up daily [rostering syncs](#) with your Student Information System and Minga via direct integration with OneRoster API, Clever, Classlink or SFTP.

- **Attend a Live Training Session**

Join a group [live training session](#) to learn how to successfully use Minga and make the most of its core features.

What is Minga?

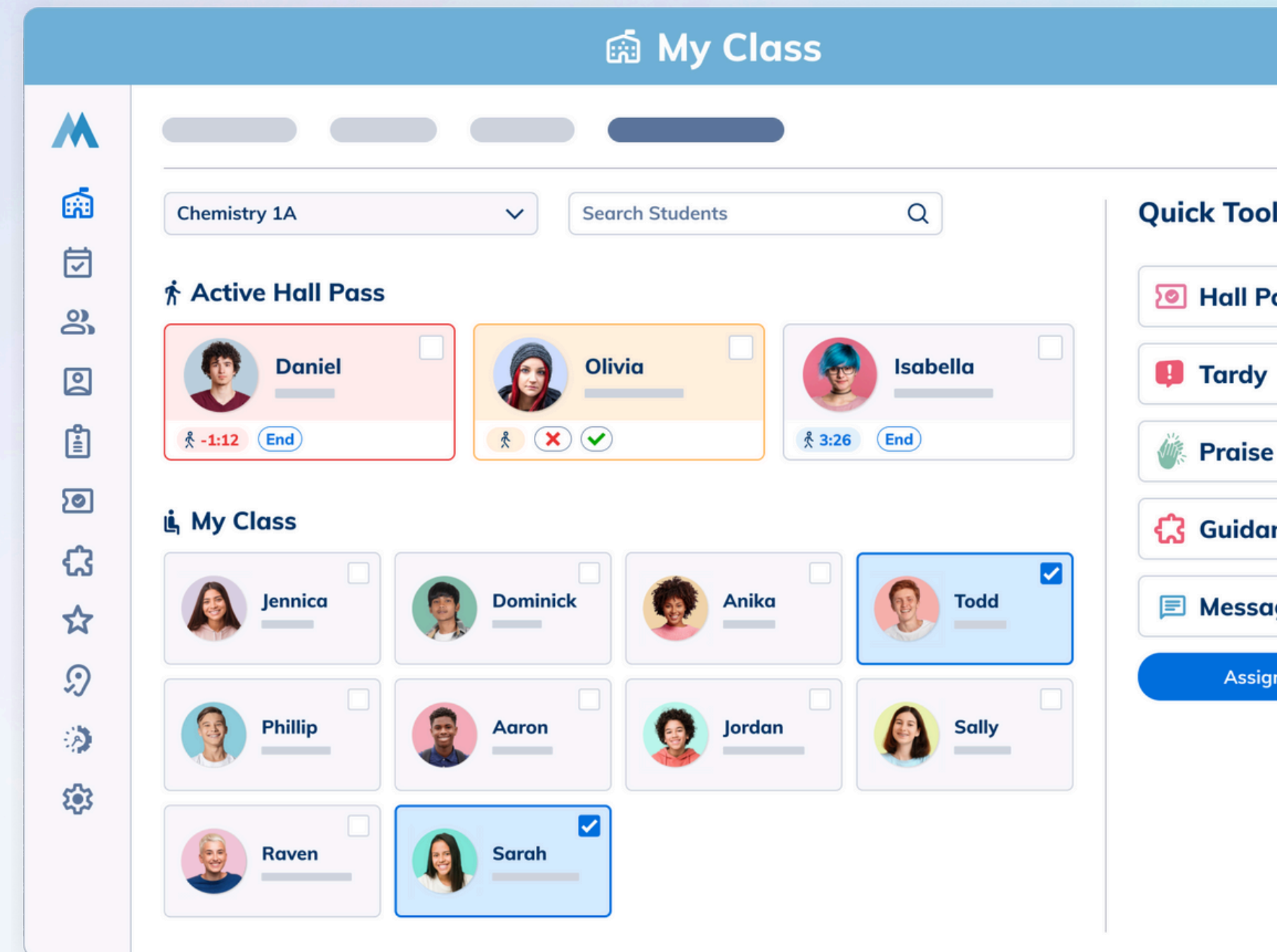


Redefining Operations for the Modern Campus

To create an account, the following information is typically used:

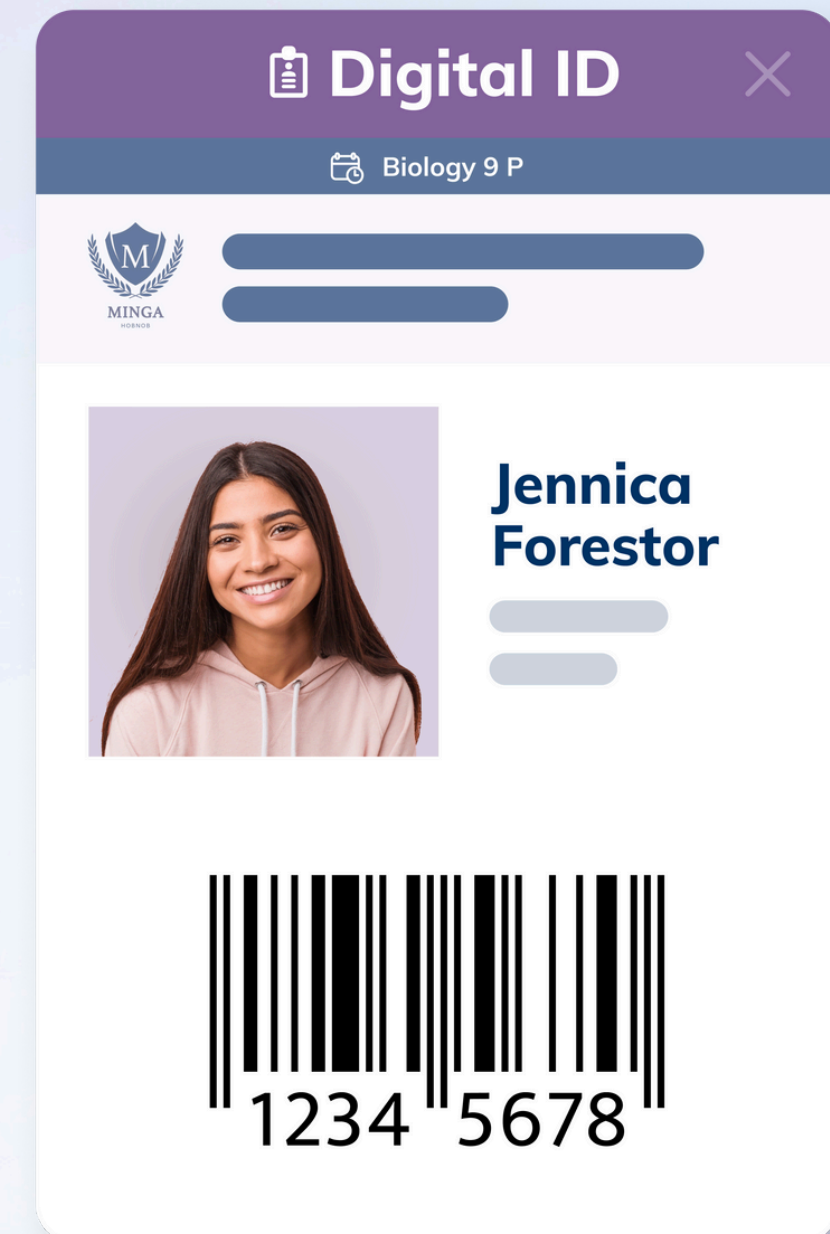
- First Name (required)

- Email Address (required)
- Parent or Emergency Contact
- Grade (optional)
- Student ID Number (optional)
- School Photo (optional)

Single Sign-On (SSO) Methods



Minga's 'Sign in with Google' functionality uses standard OAuth login. If the GSuite setup for your Google domain blocks all 3rd party services from accessing your Google accounts, you need to add the following app IDs to your access list for the domain. Without doing this, Google Sign-in will not work:

Automatic Rostering

Minga rosters directly with your Student Information System via MingaSync.

Your student and staff data will populate automatically in Minga daily via either a direct integration or SFTP depending on your needs.

We do not currently send any information back to your Student Information System.
